Potential health effects

4. First-Aid Measures

General advice:

First aid providers should wear personal protective equipment to prevent exposure. Remove contaminated clothing. Move person to fresh air. 6. Accidental release measures

Personal precautions:

Cleanup:

If application of spilled substance/product is not possible, then spills should be contained, solidified, and placed in suitable containers for disposal. 7. Handling and Storage

Handling

General advice:
